1	Covid-19 virus: General	Staff Pupils Visitors Contractors	<ul> <li>PPE provided, as required following specific current guidance for the protection of Covid-19 detail type and standard, as applicable:</li> <li>PPE resource box available in all classrooms plus the Reception office, each containing;</li> <li>Disposable half face masks</li> <li>Disposable gloves</li> <li>Disposable aprons</li> <li>Where personal care is to be provided eye protection/surgical face mask: full-face isolation shields and glasses are available. Each staff member to assemble their own visor to limit cross contamination</li> <li>PPE, as above, provided by LCC and purchased by school.</li> <li>School has purchased two hand-held infrared thermometers to test individuals' temperature as needed. (Only when someone complains of feeling hot. They are stored in Reception and HT offices)</li> <li>Designated cupboard for PPE identified (<i>Cupboard in the reading area of the foyer</i>)</li> <li>All used PPE should be double bagged and disposed of appropriately. Supply of plastic bags available in the Site Manager's office and Reception office. Store safely and securely in a lidded box in the Site Manager's office for at least 72hrs before disposing via the normal waste stream.</li> <li>Staff may wear PPE in classrooms/ offices if they wish to, this would be a personal decision. 1	Covid-19 virus: General	Staff Pupils Visitors Contractors	All staff informed that hands should be washed regularly as per Government guidance. Hygiene station set up in each classroom/ room/ resource area with soap, disposable paper handtowels and hand sanitiser. Automatic hand sanitisers are located throughout the building; mainly at access/ egress points and resource areas. Hand sanitiser is provided by "Concept Hygiene", with whom there is a Service Level Agreement (SLA). Minimum of 70% alcohol in every application. Pupils regularly reminded, in age appropriate ways, that hands should be regularly washed as per Government guidance. Teachers in each classroom to make planned provision for throughout the day using classroom facilities while maintaining social distancing. School encourages good respiratory hygiene by promoting "Catch it. Kill it. Bin it." Posters displayed in prominent areas around school; including all toilets. Additional personal storage for change of clothes for staff due to alternative travel getting into work e.g. cycling, walking, running. <i>(Lidded box per person located in the staffroom)</i> Parents/ Guardians kept informed via email bulletins etc. regarding proposals for reopening including start finish times and any new local rules regarding drop of and pick up etc. Staff kept informed via email, online meetings, telephone calls etc. Post-incident de-briefing carried out for anyone involved in an incident of suspected contamination, with the aim of providing support and preventing incident recurrence. Further support provided to all staff members affected by the incident. All incidents reported to the Health and Safety Unit, using the LCC online accident and incident report form. (MDS v7)	L*

2	Covid-19 virus; General school environment	Staff Pupils Visitors Contractors	<ul> <li>Reference made to HSE guidance for reporting under RIDDOR:</li> <li>HSE RIDDOR reporting of COVID-19</li> <li>Both school gates on South Hill Road will be opened to the school grounds to dilute the numbers coming through them as much as possible.</li> <li>Members of SLT to be present on the playground to direct parents and children, at the start and end of each day. There is a one-way system in place.</li> <li>Markings to be laid out on the playground for classes to line up at playtimes and lunchtimes – lines laid out to maintain 2m social distancing.</li> <li>Children to walk straight into the building at the start of the day; maintaining 2m distance between each other.</li> <li>Parents to handover and collect their child at the designated location on the yard. All parents and carers are required to wear a face covering.</li> <li>All visitors to site (Y7 aged and over) required to wear a face covering in order to gain access to the premises.</li> <li>School first aid risk assessment to be reviewed, as required: week of 19.4.21</li> <li>School signing-in systems are disabled during the Covid-19 pandemic: Staff members are to make their presence on site known verbally to office staff who will record attendance.</li> <li>Staff members are to inform the Reception staff (in the first instance) or the HT/ DHT of their departure off site; regardless of the time of day.</li> <li>If other visitors come to site, the same procedures as for staff will be used. 2	Covid-19 virus; General school environment	Staff Pupils Visitors Contractors	<ul> <li>Children are organised into "bubbles" so as to facilitate <i>track and trace</i>.</li> <li>N and R cohorts are one EYFS bubble (26 children in total)</li> <li>Y1 and Y2 cohorts are one KS1 bubble (35 children in total)</li> <li>Each KS2 cohorts are a bubble each; Y3 @ 30 children, Y4 @ 30 children, Y5 @ 22 children and Y6 @ 30 children</li> <li>Bubbles will not mix with each other. Staggered lunchtimes and playtimes facilitate social distancing.</li> <li>Wherever possible staff members working with a cohort will also remain in this bubble.</li> <li>All unnecessary items are removed from classrooms and teaching environments as much as possible.</li> <li>As much as possible, manipulative resources will be bubble-based and used by children within that bubble alone. Where resources are needed to be used elsewhere they will be cleaned and quarantined before being used by another bubble. Plastic resources are to be quarantined for 72hrs and all other resources quarantined for 48hrs before use. 3	Covid-19 virus; School reception and offices	Staff Visitors	<ul> <li>Staff instructed to send information electronically to avoid the use of internal mail services.</li> <li>All returned visitor passes, keys or fobs are kept stored separately from other items and cleaned and sanitised before reissue. The use of lanyards is suspended for visitors. Stickers, colour-coded with our safeguarding policy, are issued instead so that they can then be thrown away.</li> <li>Seating, display stands and magazines in the general reception area are organised so as to facilitate social distancing.</li> <li>Visitors to Reception are instructed to wait in the designated area and to communicate with staff members from the identified place. Reception staff members have the choice of wearing additional visor or face covering.</li> <li>Only one visitor or two members of the same household at-a-time is permitted in the Reception area. Standing locations 2m apart for visitors to wait outside Reception, and is 2m away, can the next person enter.</li> <li>Staff who are able to work from home, are encouraged to do so, as per current guidance. This includes staff members who are CEV and have a shielding letter (including any who are 28+weeks pregnant – NONE)</li> <li>Office windows are opened where practical, to encourage as much natural ventilation as possible (See section 8 of: CIBSE COVID-19 VENTILATION GUIDANCE (Version 4, 23 October 2020)</li> <li>Workplace layouts are configured to allow staff to maintain social distancing of 2m when they are seated at workstations.</li> <li>Desk configuration and allocation are such that staff are not seated facing each other.</li> </ul>	L*

Additional cleaning stations are to be provided for staff to use and replenished as required.</li> <li>A clear desk policy is in place. All work items and belongings are stored in desk pedestals or store cupboards when not in use.</li> <li>Telephones must not be shared and staff should transfer calls rather than pass handsets to colleagues. Where this is not possible, callers are provided with an alternative number to call back.</li> <li>The use of copiers, printers and shredders is for essential school use only. Where it is essential to use such devices, they should be cleaning materials are available. 4	Covid-19 virus: Meetings	Staff Visiting professionals	<ul> <li>All in-person meetings should be avoided whenever and wherever possible. Staff should use other means of remote communication to host meetings where facilities are readily available.</li> <li>Attendance at meetings is limited to those essential attendees only. Critical information is cascaded to other staff.</li> <li>"Blue Room" meeting room capacity is reduced to comply fully with prevailing social distancing measures. In the event that face-to-face meetings are organised (CIN core group, SLT) no more than 6 people will be permitted in the room. Meetings with more people will be conducted in one of the two halls so as to facilitate further 2m social distancing.</li> <li>Whenever possible, meeting rooms should be adequately ventilated with external windows opened during meetings.</li> <li>Meeting room users advised not to share equipment during meetings i.e. pens, stationery etc. Attendees to remove all items following the meeting.</li> <li>Meeting room hosts are to wipe down surfaces (including any buttons on IT equipment and remote controls) following meetings. Additional cleaning materials will be provided in all meeting rooms for use by staff and replenished as required.</li> </ul>	L*

5	Covid-19 virus: Classrooms	Staff Pupils	<ul> <li>Meetings to take place promptly and conclude fully in the meeting room to avoid attendees congregating in adjoining areas prior to and following meetings.</li> <li>Face-to-face meetings between parents and staff members are discouraged. Telephone and/ or virtual meetings are promoted.</li> <li>Primary Schools (including those with Nursery provision): <ul> <li>Minimise mixing within settings e.g. different rooms for different age groups</li> <li>N and R cohorts are formed into 1 bubble and will become a self-contained unit.</li> <li>EYFS parents will drop their children off at the appropriate door and leave their child in the care of the staff members.</li> <li>Classes are kept in 'bubbles' and should not mix with other classes during the school day</li> <li>Wherever possible, staff teaching and supervising a 'bubble' should maintain 2m social distancing from pupils and should not mix with other bubbles.</li> </ul> </li> <li>All desks face the same direction i.e. front of the classroom whenever possible.</li> <li>Pupils, wherever possible, are seated side-by-side as opposed to opposite each other.</li> <li>For individual and very frequently used equipment, such as pencils and pens, staff and pupils have their own which are not shared.</li> <li>Resources shared between bubbles, such as sports, art and science equipment, should be cleaned frequently and meticulously and always between use by different bubbles, or rotated to allow them to be left unused and out of reach for a period of 48hrs (72hrs for plastics) between use by different bubbles.</li> </ul>	L*

7	Covid-19 virus; School day	Staff Pupils Visitors Contractors	<ul> <li>School end times for the different bubbles are staggered to reduce the numbers attending the site at the start and finish of the day.</li> <li>Children are supervised as they enter and leave the site individually (as parents/ carers are present on the yard). 2m distance is maintained at all times</li> <li>Parents and guardians are requested to drop their children off alone e.g., not both parents attending at once</li> <li>Parents and guardians are requested not to gather at entrance gates or doors, or enter the site (unless they have a pre-arranged appointment) once their children have entered the school</li> <li>Parents and guardians requested not to gather on the school playground and to maintain social distancing at all times. Designated "holding" areas are identified for different bubbles in the event that their parent/ carer is late in coming to collect them.</li> <li>All parents/ Carers are requested to wear a face covering. If not possible, proof of exemption will be asked for.</li> <li>A member of SLT to stand near the entrance and exit gates on the yard to ensure adherence to the above.</li> <li>All children who are left at the end of a day will wait along the lower corridor in bubble or family groups; maintaining 2m distancing. Tape markers on the floor demarcate areas</li> <li>Timetables are revised where possible to reduce the movement around the school premises and to stagger busy transitional periods.</li> <li>Break times (including lunch) staggered for classes to minimise mixing and dilute numbers using common areas such as walkways and toilets.</li> <li>Where possible the numbers of pupils using toilets will be managed.
